Treasurer Report – Bruce Rumbold – fiscal year 6/1/2024 to 2/28/2025

Revenue \$ 5,900.74 (increased insurance costs)

Expenses \$ 7,198.53 (deficit of \$ 1,297.79)

Total cash assets \$ 16,673.93

BNA members paid 198 (29% of total households)

Dede suggested to offset liability insurance expense's we might consider sharing costs with North Winton Village policy. Pros and cons were discussed. Holly offered to call NWV to inquire about them adding us on their policy and sharing the expense.
