

BROWNCROFT ROSE GARDEN PROJECTS

FALL CLEAN-UP

Volunteer neighbors met in the Rose Garden Saturday morning, October 22nd, to prune and winterize the rose beds, weed the annual bed and generally pick-up the park.

CIRCULAR BED

SNOW REMOVAL and SIDEWALK PLOWS

The property owner's responsibility:

Per City Code, it is the responsibility of property owners to remove snow from the sidewalk in front of their property. For people with physical disabilities, even one inch of snow on the sidewalk can drastically impede movement. Please clear the snow so all can go! BNA Tip: Make sure your walkways and front steps are clear of snow and ice. Letter carriers and delivery workers have a difficult job traversing walkways this time of year.

The City's role:

The City of Rochester provides supplemental service to help property owners clear their sidewalks during a substantial winter storm. The City plows sidewalks when 4 inches of new snow has accumulated.

Sidewalk snow plowing facts:

• The City plows sidewalks when 4" of new snow has freshly fallen, dependent upon weather events and forecasts, and the condition of the sidewalks.

• The City plows all sidewalks that are at least five feet in width.

• Each sidewalk plow run takes about five hours to complete.

• The City plows 878 miles of sidewalks. These miles are divided into distinct sidewalk plow runs of approximately 15 miles.

• Depending on the severity of a storm, sidewalk snow plowing policies must sometimes be altered to meet the needs of the situation.

• The City uses private con-

tractors to plow sidewalks.

• Sidewalk plowing usually happens in the evening and early morning when pedestrian traffic is lowest, but this schedule is modified to respond to actual storm conditions.

Fees:

Sidewalk snow plowing is financed by an embellishment fee on your property tax bill that is based on the front footage of a property. (Excerpt from the City of Rochester website)

Tip from the BNA -- You can reduce damage to your property by checking to make sure bushes or trees that abut your sidewalk or tree limbs that reach overhead are not causing the driver to swerve cutting into the lawn. IMPORTANT: If the sidewalk plow has damaged your property make sure to contact the City at 311.

FIRE HYDRANTS

Each year fires occurring during the winter season injure thousands of individuals and cause millions of dollars in damages. There are simple life-saving steps we can take to ensure our safety. By following some of the outlined precautionary tips, individuals can greatly reduce their chances of becoming a fire casualty. One of these tips is fire hydrant protocol.

Remove snow surrounding a fire hydrant: While many welcome our winter wonderland, did you know that snow could cause a great fire risk to your home? If a fire hydrant is buried in the snow, that's not a good thing if your home catches fire.

An uncleared fire hydrant could cost firefighters that precious time needed to protect your home and family. Fire hydrants may also freeze causing the inability of the hydrant to flow water during a time of an emergency.

It is the property owners responsibility to keep the fire hydrants clear.

BNA Garage Sale Returns in 2017

The BNA Garage Sale returns for the twentieth time the weekend of **May 6 and 7**. This biennial event, occurring in the odd numbered years, is a popular Rochester happening.

Approximately 150 households usually participate, holding their own garage sales in their yards. Hundreds, if not thousands, of visitors walk and drive through the neighborhood looking for bargains and collectibles.

BNA does publicity by running an ad in the newspaper; posts "BNA Garage Sale" signs on the perimeter of the neighborhood; catalogues the items for sale by address and posts it on the BNA web site; purchases insurance for the event; and contracts for portable toilets to be placed at 46 School and in the Browncroft Rose Garden.

A nominal registration fee of \$5.00 per participating household is charged. This is quite a bargain considering the expenses BNA incurs and the profits that our residents tend to gain off of the traffic such an organized event generates.

Demolition on Winton Rd for Aldi Development

Demolition of the existing structures at the proposed site for the Aldi store has occurred at the north west corner of Winton and Blossom Roads. Gone are the



buildings which had been vacant for over a year -- Jim's Diner, three houses, a barn, Earl's Garage, and Roly Door.

The developer for Aldi, banking on a favorable court outcome, decided to assume the risk to proceed with demolition prior to any decision of the Appellate Division of the Supreme Court of the appeal of Tops and RERAD to the April 2016 Zoning Board of Appeals' approval of the Aldi project. The developer had filed a motion to expedite the decision; however, it was denied by the court. The hearing is expected to proceed no earlier than April 2017, with a decision to follow in May.



Browncroft Neighbor to be new CEO of Center for Dispute Settlement

Frank Liberti, of Browncroft Boulevard, is to be the new president and chief executive officer of the Center for Dispute Settlement effective January 1st.

Frank has been with the dispute center for many years, beginning as a board member in 2002, and later as the director of police community relations programs. His prior professional experiences include labor relations and contract negotiations, having held positions in both the private and public sectors.

The Center for Dispute Settlement is a not-for-profit corporation founded in 1973, and was the first organization in New York State to provide mediation, facilitation, fact finding and arbitration services. It enables individuals and organizations to resolve conflicts without going to court. Today they serve the counties of Monroe, Wavne, Ontario, Yates, Seneca,

Cayuga, Steuben and Livingston.
